NEW YORK, Sept. 26, 2017 (GLOBE NEWSWIRE) -- National General Holdings Corp. (NASDAQ:NGHC) today announced that it expects its third quarter 2017 results to include \$25-30 million in losses (\$17.5-21 million after-tax), net of quota share reinsurance recoverables, relating to Hurricane Harvey which made landfall in Texas in late August. The range in our estimate is driven by uncertainty surrounding the potential for additional claim information to emerge. National General writes home, auto and lender services coverage in the state of Texas.
